## **Condition Codes**

### Excellent = 4

"Excellent" condition means the vehicle looks new, is in excellent mechanical condition and needs no reconditioning. This vehicle has never had any paint or body work and is free of rust.

The vehicle has a clean Title History and will pass a smog and safety inspection. The engine compartment is clean, with no fluid leaks and is free of any wear or visible defects. The vehicle also has complete and verifiable service records. 5% of all used vehicles fall into this category.

### Good = 3

"Good"\_condition\_means\_that\_the\_vehicle\_is\_free\_of\_any\_major\_defects.\_This\_vehicle\_has\_a\_clean\_Title\_History,\_the\_paint,\_body\_and\_interior\_have\_only\_minor\_(if\_any)\_blemishes,\_and\_there\_are\_no\_major\_mechanical\_problems.\_There\_should\_be\_little\_or\_no\_rust\_on\_this\_vehicle.\_The\_tires\_match\_and\_have\_substantial\_tread\_wear\_left.\_\_\_"good"\_vehicle\_will\_need\_some\_reconditioning\_to\_be\_sold\_at retail. Most consumer owned vehicles fall into this category.

## Fair = 2

"Fair"\_condition\_means\_that\_the\_vehicle\_has\_some\_mechanical\_or\_cosmetic\_defects\_and\_needs\_servicing\_but\_is\_still\_in\_reasonable\_running\_condition.\_This\_vehicle\_has\_a\_clean\_Title\_History,\_the\_paint, body and/or interior need work performed by a professional. The tires may need to be replaced. There may be some repairable rust damage.

#### Poor = 1

"Poor"\_condition\_means\_that\_the\_vehicle\_has\_severe\_mechanical\_and/or\_cosmetic\_defects\_and\_is\_in\_poor\_running\_condition.\_The\_vehicle\_may\_have\_problems\_that\_cannot\_be\_readily\_fixed\_such\_as\_a\_damaged\_frame\_or\_a\_rusted-through\_body.\_\_\_vehicle\_with\_a\_branded\_title\_(salvage,\_flood,\_etc.)\_or\_unsubstantiated\_mileage\_is\_considered\_"poor."\_\_\_vehicle\_in\_poor\_condition\_may\_require\_an\_independent appraisal to determine its value.
